Rushern Baker





Access to affordable healthcare is a challenge that far too many have to face - particularly aging adults and young adults whose employers do not offer health insurance. As the primary caregiver to his wife who was diagnosed with early onset Alzheimer's, Rushern Baker understands first-hand the financial strain that quality healthcare and prescription medication can put on a family. No one should have to forego healthcare because of the cost and no family should have to go into debt if there is an emergency. This is why Rushern Baker fights for affordable healthcare, invests in modern healthcare facilities, and is

working to attract more doctors to our region.

Marylanders deserve to be represented by someone who shares their values. Rushern has released a comprehensive, first-in-the-nation plan to combat sexual harassment and sexual violence in Maryland, but mothers and their families need more than a harassment free work environment to thrive. Rushern has proposed providing 3-months of guaranteed paid family leave for every new mother and father in the State. No one should have to choose between caring for their child or ailing parent and putting food on the table.

Education directly impacts economic opportunity, and no one knows this better than Rushern Baker. As a student, he struggled with reading and had to repeat first and second grade. Because of the support of good teachers, he went on to become the first in his family to graduate from college. The opportunities he has been given by blessing should be available to everyone by right, no matter where you live. This is why, as County Executive of the second largest county in the state, he worked to improve education, prioritized quality economic development projects that produced the greatest return on investment and created good-paying jobs in struggling communities by raising the minimum wage. Government Accountability and Transparency

Bio

Rushern Baker was elected as County Executive of Prince George's County in 2010, and continues to serve in that position. He was born in Georgia. The family then settled in Massachusets. Rushern has talked about his early struggles with reading and attributes the dedication of his family and teachers to helping him overcome difficulties and succeed academically. He received his bachelor's degree and Juris Doctor (JD) from Howard University in 1982 and 1986, respectively.

He met his wife Christa at Howard, and after college they lived in Cheverly and raised their three children.

Rushern represented District 22B in the House of Delegates from 1994 to 2003, was a member of the Bar and worked for Baker and Perry law firm for several years, and served as Executive Director for the Community Teacher's Institute. Among many other boards and organizations, he served on the board of the American Civil Liberties Union of Maryland and Leadership Maryland, and as President of County Executives of America.

These principles are the keystone for getting people in government who are really public servants.

Until we have politicians who are committed to doing what is in the best interests of the people they serve, rather than their own personal gains, we will not get a handle on any of the problems that confront our state.

Education and Crime

We need an educational system and program that gives students hope instead of hopelessness. Too many students wind up lost and on the wrong side of the tracks.

My TUTOR-MENTOR TEAM PROGRAM is designed to steer and keep students on the right path to a life of success. Students are given an opportunity to connect with a TUTOR-MENTOR TEAM who will stay with him/her from the moment of linking up until the student graduates from high school and/or college and is gainfully employed.

An essential component to the Tutor/Mentor Program involves taking a new look at the curriculum.

I submit that our present system of public education is not meeting the needs of the students. Students in the public schools are victims of "classroom prison-like education," confined approximately 7 hours a day, 5 days a week, 10 months a year to a setting of classroom walls. Couple this with the teachers with the daunting challenge of educating and entertaining their students 6 or 7 hours a day, 5 days a week, 10 months a year. So...is it hard to understand why students could easily become bored and fed up in the classroom? I believe that teachers are overworked and underpaid. They deserve higher salaries.

The TUTOR-MENTOR TEAM program is the long term solution to the horrific problem that Baltimore City is facing.

Nursing Homes

The treatment of the elderly in nursing homes can be labeled as disgraceful. Unless the resident has tons of money to pay for special service, it comes as no surprise that the residents are often victims of negligence and mistreatment. I have expressed concerns about understaffing and safety in these facilities for the last 20 years. Having served as a volunteer in a nursing home for 10 years, I saw first hand what goes on. I am currently a volunteer in another nursing home.

If elected governor of the state of Maryland, I am going to make this a major priority by trying to persuade the state legislature to pass legislation to improve conditions for the residents who must reside in these so-called homes for the elderly and the needy. Part of the solution is a ratio of no more than 6 patients to 1 nurse's aide.

Bio

Mr Jaffe is a high school social studies teacher, not a politician. He now has his own public policy institute. Education

As governor, Education will be my top priority. Jobs

Healthcare

Bio

Ben's mother grew up in Baltimore public housing and helped integrate Western High School as a member of the NAACP's Youth and College Division. His father was one of the few white men jailed during the Congress of Racial Equality's efforts to desegregate Baltimore's downtown business district.

A Marylander throughout his career, Ben served as the president of the Rosenberg Foundation and was founding director of Amnesty International's U.S. Domestic Human Rights Program.

At 35, Ben became the youngest-ever President of the NAACP. Under his leadership, the NAACP increased membership three years consecutively for the first time in 20 years, opened national programs in education, health and environmental justice and worked on the economy and voting rights. In 2013, the Baltimore Sun named Ben Marylander of the Year because of his leadership efforts to abolish the death penalty, to pass marriage equality, to pass the DREAM Act, and to expand voting rights.

Ben manages Kapor Capital's Baltimore office where he has invested in several Maryland companies working to make our state stronger.

Ben is a graduate of Columbia and Oxford University (Rhodes Scholar). He is the proud father of two children who attend public schools.

Restoring Maryland's Schools to the Nation's Best

For years, Maryland's schools were ranked the best in the nation, but under Governor Hogan's watch, we are slipping down the list. As governor, Kevin will restore Maryland's schools to the nation's best by:

- Prioritizing early childhood education to provide universal pre-K to prevent achievement gaps before they begin.
- Updating funding formulas to support historically disadvantaged jurisdictions so that the quality of a child's education is not dependent on their zip code.

Rick Madaleno



High Quality Education

Rich Madaleno is committed to making an excellent public education available to every child in Maryland. Currently a member of the state's Commission on Innovation & Excellence in Education (Kirwan Commission), he will ensure adequate funding to build a 21st century public school system; recruit, support and retain high quality teachers; build and support community schools; and expand pre-kindergarten programs. Building on his successful Hunger-Free Schools and Meal for Teens laws which brought free breakfasts and lunches to eligible school children, he will expand free lunches and breakfasts to those qualifying for reduced-price meals because ensuring good nutrition is an approach which improves students' learning.

Fair Economy

Rich Madaleno is fighting for working families, and is the lead sponsor of legislation to raise Maryland's minimum wage to \$15.00 per hour. Building on past successes in expanding the Earned Income Credit, Rick seeks to make that credit available to more Marylanders, including those under 25 years of age who are childless. Education

Talent is everywhere, but opportunity is not. I learned this firsthand when I taught 6th grade at Booker T. Washington Middle School in Baltimore. Many of my students were brilliant, but I knew they would struggle to succeed because of where they came from and what lay ahead. We have a once every 15 year opportunity with the Kirwan Commission to fix how we fund our schools, and my background as a teacher guides my belief that we need to reset the funding formula for our schools and bring equity to school financing so that the quality of a child's education isn't determined by the zipcode they live in.

Jobs & the Economy

We must build a more inclusive economy that works for everyone in Maryland. That starts with helping people get new job skills and matching employers to talented people that bring energy and knowhow. Technology changes everything in tomorrow's economy. It's not a slice of the economic pie. It's the pan. We must ensure that every Marylander has the opportunity to compete and succeed in this techdriven world. It's not just about finding a job. It's about finding the right job with a path to greater prosperity for families. Wages have been stagnant for too long, and working families need a raise.

Small businesses are the backbone of our economy, yet our government still focuses too much of its efforts on recruiting industry giants instead of supporting Maryland-based entrepreneurs and businesses. Maryland cannot place all its bets on trickle-down benefits from large corporations. We've got to build up from the bottom by investing in hard-working people.

Universal computer science education

For only \$10 million/year, we can make sure our students are on the path to succeeding in the industries of the future.
